Living Conditions

Yangon is the capital of Myanmar. The population is about 5 million but has more a feel of a small town, though the city is developing quickly with the associated annoyances of traffic and construction. The climate is tropical with three seasons, temperatures reaching 40 Celsius in the hot season and the rainy season is characterized with very heavy rains and flooding. There is an expanding and active expatriate community in Yangon. There are some international kindergartens and schools. Several restaurants around the city serve local or international cuisine and there are numerous social and cultural events throughout the year organized by the international and local communities. Sports facilities (fitness, tennis, swimming golf, gyms etc.) exist in different establishments around the city.

Housing of western standard is a bit difficult to find affordably due to the influx of expatriates and not enough supply. Rental prices are high. However, with the demand and new openness of the country, apartments and flats are becoming more available. The basic infrastructures - roads, utilities, and telecommunications - are below standard, as are medical facilities, which are still largely inadequate, although a few private clinics and hospitals provide reasonably good routine care. Most foodstuffs, beverages, household goods, furniture and clothing are imported from neighboring countries. Western quality goods can be found, although they can be expensive. Meat, fish, fresh fruits and vegetables are cheap and abundantly available.

UN Youth Volunteer in Supporting Child-Friendly Justice Reforms

Organizational Context & Project Description

Myanmar is transitioning at a rapid pace, politically, economically and socially. Representing over 34% of the population, children are increasingly affected by these rapid changes. One in five children are actively working in Myanmar. Reports on violence against women and children and gender inequality have become more widely discussed and reported as the media liberalises and social media becomes commonplace. Domestic violence against girls and boys is being reported directly by families and communities to authorities in greater numbers, with the anticipation of a response by government and civil society. Urban migration is increasing the number of children who work and/or live on the street. And the number of reported cases to the Myanmar Police Force of child victims of sexual abuse has risen significantly in 2015 and 2016 compared with previous years.

In this context, acceleration of social welfare and justice system reforms, development of child friendly legislation, policies and services is critical. UNICEF in Myanmar is supporting child protection systems building and child-friendly legislative and policy reforms in the context of social/child protection and justice systems. Child Protection Section of UNICEF Myanmar works on a wide variety of issues including child care and protection reforms, violence against children, alternative care, child protection in emergencies, mine action, children and armed conflict, child migration and trafficking, child labour, legislative reforms, and establishment of child-friendly justice systems.

The UN Youth Volunteer will be working in UNICEF Myanmar's Country Office in Yangon. The UNV will be part of the Child Protection Section and will directly support the Justice for Children team that works on legislative reform and children's access to justice, capacity building of justice system counterparts, as well as migration, trafficking and child labour. The UNV will be supervised by the Child Protection Specialist heading the Justice for Children team, will work closely with 2 Child Protection Officers, and will be in daily contact with the broader child protection team in Yangon and in various field offices.

Task description

Under the direct supervision of Child Protection Specialist (Justice for Children), the UN Youth Volunteer will undertake the following tasks:

Contribute to the development of secondary legislation (Rules and Procedures) for Myanmar's revised Child Law by conducting research on relevant international law and best practices;

Participate in development and roll-out of juvenile diversion programme in Myanmar by supporting the process with required research, coordination and drafting;

Support the child protection team with drafting issue briefs and policy papers on children's access to justice, use of detention, the rights of migrant, displaced and refugee children and other issues related to the rights of children in contact with the justice system;

Support ongoing analysis of policies and laws related to child protection and the rights of children (including anti-trafficking laws, labour laws, migration laws, various criminal legislation);

Support the Justice for Children team in identifying models of sustainable capacity building of police and judiciary, and on-the-job support mechanisms.

Furthermore, UN Volunteers are required to:- Strengthen their knowledge and understanding of the concept of volunteerismby reading relevant UNV and external publications and take active part in UNVactivities (for instance in events that mark International Volunteer Day)- Be acquainted with and build on traditional and/or local forms of volunteerism in the host country- Reflect on the type and quality of voluntary action that they are undertaking, including participation in ongoing reflection activities- Contribute articles/write-ups on field experiences and submit them for UNVpublications/websites, newsletters, press releases, etc.- Assist with

The contract lasts for the period indicated above with possibility of extensions subject to availability of funding, operational necessity and satisfactory performance. However, there is no expectation of renewal of the assignment.

A UN Volunteer receives a Volunteer Living Allowance (VLA) per month and is paid at the end of each month to cover housing, utilities, transportation, communications and other basic needs. The VLA can be computed by applying the Post-Adjustment Multiplier (PAM) to the VLA base rate of (choose from the drop down menu the appropriate rate here): US\$1270. The VLA base rate is a global rate, while the PAM is country-specific and fluctuates on a monthly basis according to the cost of living. This method ensures that international UN Volunteers have comparable purchasing power at all duty stations irrespective of varying costs of living. The PAM is established by the International Civil Service Commission (ICSC) and is published at the beginning of every month on the ICSC website https://icsc.un.org.

In non-family duty stations that belong to hardship categories D or E, as classified by the ICSC, international UN Volunteers receive a Well-Being Differential (WBD) on a monthly basis.

Furthermore, UN Volunteers are provided a settling-in-grant (SIG) at the start of the assignment (if the volunteer did not reside in the duty station for at least 6 months prior to taking up the assignment) and also in the event of a permanent reassignment to another duty station.

UNV provides life, health, permanent disability insurances as well as assignment travel, annual leave, full integration in the UN security framework (including residential security reimbursements).

UN Volunteers are paid Daily Subsistence Allowance at the UN rate for official travels, flight tickets for the final repatriation travel (if applicable). A resettlement allowance is paid for satisfactory service at the end of the assignment.

UNV will provide, together with the offer of assignment, a copy of the Conditions of Service, including Code of conduct, to the successful candidate.
