## Living Conditions

Mongolia is located in the heart of the Asian continent and covers an area of 1,566,500 square kilometers. Mongolia's climate is extreme continental - an extreme climate with seven to nine months where the mean temperature remains below freezing point. Higher temperatures occur for two or three months in summer. The winter months begin from October and last until mid-April. The coldest months are from mid-December to the end of February or mid-March when the temperature drops to below zero to minus 20 degrees centigrade and occasionally even lower. The spring is usually characterized by violent dust storms, gusty winds and constant changes in pressure. Social, economic and health situation are the main factors that affect the security situation in Mongolia while it is generally a peaceful country without any security phase.

The official language, Mongolian, is spoken and understood throughout the country, while Kazakh is spoken by a minority in Western Mongolia. Russian is extensively spoken and English is becoming more popular in urban areas. Ulaanbaatar has fairly good international flight and train connections. With regular flights every day operated by four different airlines, travel by air is the most convenient and fastest means of travel to and from Ulaanbaatar. The Trans-Siberian and Trans-Mongolian trains connect Ulaanbaatar with Europe and Asia. All important locations in the country are accessible by air and road.

There are many privately owned apartment compounds with competitive rentals for short and long term in the centre of the city. There are many real estate agencies with numerous secure apartment options available – including within walking distance to the office. Taxis are also readily available and can be organized to a daily routine. In Ulaanbaatar one can find any suitable place to live, food to eat and clothing to wear without much problem. Electricity, phone, internet, shops, banking, medical, recreation and entertainment are all available.

There are no immunization and or vaccination requirements for people entering Mongolia. International telephone, internet and fax services work well in Ulaanbaatar. There are several cellular telephone operator companies. Internet service is very popular in Ulaanbaatar at reasonable rates and wireless facilities are available in many locations.

Foreigners can rent fully furnished apartments in any part of the city. Medical and dental services are available for international personnel in Ulaanbaatar.

#### **UNICEF Mongolia**

UNICEF's cooperation with the Government of Mongolia began in 1963 providing technical assistance in immunisation, breastfeeding and reduction of iodine deficiency disorders. An office was opened in Mongolia in 1991.

Despite substantial improvements during successive five-year plans, many challenges remain in a country where economic development is outstripping human development.

The overall goal of the current country programme is to narrow inequality gaps where child disparities are most prevalent, while making the new generations an area of strategic investment as a foundation for the Country's human capital and sustainable development. This goal will be achieved through the combined interaction of four outcomes, aimed at narrowing inequality gaps and strengthening the overall policy and normative environment for children.

The 2017 - 2021 country programme thus entails the following programme components:

Child Survival and Development

Inclusive, Healthy and Quality Learning Environments

Equitable Social Policies and Protective Systems

With an emphasis on equity and investment in the youngest members of society, the country programme will directly contribute to Mongolia's Sustainable Development Vision 2030, and in particular to its goals of sustainable social and green development.

The programme's strong equity focus will target most disadvantaged children and families with little or no access to quality services. The focus will be on areas where the programme can add most value and ensure highest operational efficiency, as highlighted by programme reviews and evaluations.

The programme will reach the most disadvantaged children through a combination of central and local level interventions. Support to pro-child and pro-equity national social policies and legislation will be instrumental to strengthen child-friendly local governance and quality service delivery at the sub-national level. The programme will demonstrate affordable, integrated and effective solutions to tackle inequalities at local level, while national policy and budget advocacy will ensure replication and sustainability at a larger scale, thus maximizing the catalytic effect of funding. Provision of high quality technical assistance as well as linkages to global knowledge and best practices will be important strategies to support social and economic policies, and legal reforms. This will be supported by generation of data and production of research, as well as a continued investment in evaluation and knowledge management.

Child Survival and Development is one the three programme components of the UNICEF Country Programme 2017-2019 and UNICEF supports the Government in achieving the SDG 3 (Good health and well-being), which aims to ensure that the most disadvantaged children in Mongolia benefit from increased access and utilization of services that promote health and nutrition, including water, sanitation, hygiene and interventions that mitigate the impact of air pollution on children. The component specifically addresses the need for a stronger equity focus to improve access to quality services for the most disadvantaged children at sub-national levels with the support of legislation, policies and budget allocation and the removal of demand barriers through improved social and cultural practices and awareness. Capacity development of national and local authorities will ensure sustainability of interventions, including for contingency plans and preparedness measures in case of natural disasters. This component entails the provision of an

integrated package of Maternal, Newborn and Child Health (MNCH). This was successfully tested in the previous country programme and will be replicated to a larger geographical scale, as part of the sub-national service delivery systems.

The Health Programme also promotes the use of technology in increasing access to high-impact, low-cost health interventions including preventive health information of ante-natal care and newborn care as well as in cold chain monitoring. Specifically in 2017 - 2018, the Health Programme aims to introduce and implement nationwide a C4D (Communication for Development) strategy for Inactivated Polio vaccine (IPV), pneumococcal conjugate vaccine (PCV) and pneumonia prevention. Thus, will increase a need for both cold chain monitoring and information dissemination for parents and care takers on immunization using ICT. On the other side, health system's strengthening is a key strategy for child health programme. UNICEF is shifting from service delivery to support health system strengthening. As such, by the end of May, 2020 UNICEF aims to establish a support center for community health services at the National Maternal Child Health Center. The Center will provide a technical support for community health centers on child health and wellbeing issues and conduct a regular monitoring of community child health service in 4 focus areas. In particular, the Center will develop a real time monitoring dashboard system using a software to monitor supply and demand barriers at community health service. After pre-test and use of the dashboard system UNICEF will support use for the system nationwide gradually. UNICEF Health programme introduced several innovations for newborn and child health using telemedicine.

The International UN Volunteer will be attached to the Health Programme within the Child Survival and Development programme under the supervision and guidance of the Health Specialist. UN Volunteer will also support the Health Specialist in achieving the planned results of the Health Programme for 2018 in collaboration with the key partners at the Ministry of Health in Mongolia and its departments in 3 provinces and Bayanzurkh district.

#### Task description

Under the direct supervision and programmatic guidance of the Health Specialist, who is accountable to deliver the planned results of the Health Programme, the UN Volunteer will undertake the following tasks:

To assist in the development and implementation of ICT-supported programmatic health interventions. Also, support in strengthening and scaling up of on-going interventions such as mobile health, telemedicine and Internet Protocol Camera use for provision of remote technical guidance.

To support in designing ICT-supported communication for development strategy to increase access of children and women in preventive health information and behavioural change communication.

To support in advancing government partners in e-learning through design of ICT-supported training modules and standard operating procedures for IT usage to support health workers at sub-national levels (in Zavkhan, Gobi-Altai, Bayankhongor and Khuvsgul provinces and Bayanzurkh District of Ulaanbaatar).

To provide support developing a real time monitoring dashboard at the National Maternal and Child Health Center in preparing programme reports.

To contribute to country programmes by showcasing lessons learned, human interest stories and good practices

A UN Volunteer receives a Volunteer Living Allowance (VLA) which is composed of the Monthly Living Allowance (MLA) and a Family Allowance (FA) for those with dependents (maximum three).

The Volunteer Living Allowance (VLA) is paid at the end of each month to cover housing, utilities, transportation, communications and other basic needs. The VLA can be computed by applying the Post-Adjustment Multiplier (PAM) to the VLA base rate of US\$ 1,587. The VLA base rate is a global rate across the world, while the PAM is duty station/country-specific and fluctuates on a monthly basis according to the cost of living. This method ensures that international UN Volunteers have comparable purchasing power at all duty stations irrespective of varying costs of living. The PAM is established by the International Civil Service Commission (ICSC) and is published at the beginning of every month on the ICSC website <a href="http://icsc.un.org">http://icsc.un.org</a>.

In non-family duty stations that belong to hardship categories D or E, as classified by the ICSC, international UN Volunteers receive a Well-Being Differential (WBD) on a monthly basis.

Furthermore, UN Volunteers are provided a settling-in-grant (SIG) at the start of the assignment (if the volunteer did not reside in the duty station for at least 6 months prior to taking up the assignment) and in the event of a permanent reassignment to another duty station.

UNV provides life, health, permanent disability insurances as well as assignment travel, annual leave, full integration in the UN security framework (including residential security reimbursements).

UN Volunteers are paid Daily Subsistence Allowance at the UN rate for official travels, flight tickets for periodic home visit and for the final repatriation travel (if applicable). Resettlement allowance is paid for satisfactory service at the end of the assignment.

UNV will provide, together with the offer of assignment, a copy of the Conditions of Service, including Code of conduct, to the successful candidate.
